



## WAIVER AND RELEASE BY PARTICIPANT

I hereby understand and agree that by participating in the skateboarding contests ("Contests") sponsored by The Association of Skateboarders in Hawaii, a nonprofit corporation ("ASH"), I am responsible for my own physical fitness and assure that I am physically fit and capable to perform in this Contest. I understand all of the dangers of the sport of skateboarding, including serious property damage, bodily injury and death, and of all standard and prudent safety rules for skateboarding activities. I understand that this Contest is not intended to teach me any safety rules and that ASH will not serve as the guardian of my safety. I also understand and agree that I am responsible for the safety and good operating condition of any equipment I use for the Contest, whether it is provided by me or to me by ASH or otherwise, and that I will carefully inspect all such equipment before using it. I agree that I am responsible for my own medical and emergency expenses in case of an accident, illness or other incapacity whether or not I authorize such expenses, and I will reimburse ASH for any and all such medical and emergency expenses which may be paid on my behalf.

I understand and agree that neither this Contest nor its owners, operators, agents or sponsors, including, but not limited to ASH, its directors, officers, employees and agents, shall be held liable by me, my family, heirs or assigns, in any way for any occurrence in connection with this Contest which may result in injury, death, or other damages to me or my family, heirs, or assigns, or other property. In consideration of my being permitted to participate in this contest, I assume all risks in connection with this Contest. I forever release the sponsors, program, agents, and operators, including, but not limited to, the persons and corporation mentioned above, for any and all bodily injury or personal injury known or unknown, death or property damage caused by any accident or incident which may occur as a result of my participation in this Contest. I also agree to indemnify, defend and hold harmless such persons and entities from and against any and all liabilities, damages, costs, expenses (including attorneys' fees) demands, actions or rights of action of whatever kind or name either in law or in equity brought or caused by me, my family, heirs, assigns, or any other party arising out of my participation in this Contest.

I also grant full permission to ASH and/or its agents to use any photographs, videotapes, motion pictures, recording or other record of this Contest in any other media for any purpose at any time. I have read this waiver and release carefully and understand all the stated terms.
